#### VULNERABILITIES AND WAY FORWARD: A STUDY ON WOMEN FISHER FOLK IN THE COASTAL ZONES OF BANGLADESH

**About JAGO NARI:** JAGO NARI, a women-led rights-basedorganization, has been operating in the central coastal region of Bangladesh since 1998. The organization primarily focuses on promoting women's empowerment, improving water and sanitation, enhancing health and nutrition, ensuring quality education, and addressing climate change and disaster risk reduction. JAGO NARI is committed to safeguarding the rights of individuals affected by climate-induced disasters.

**About OXFAM:** Oxfam is a global organization dedicated to ending poverty and advancing social justice. In Bangladesh, its journey began in 1970 with humanitarian assistance to cyclone-affected communities, followed by vital support during the 1971 Liberation War. In recognition of these contributions, Oxfam was honored as a Friend of the Bangladesh Liberation War in 2012. For more than five decades, Oxfam has worked alongside Bangladesh to foster economic development, combat poverty, champion women's rights, and address the challenges of climate injustice.

#### Brief information about "A journey to become empowered women fisher folk" project:

"A journey to become empowered women fisher folk" project is funded from EWCSA project of OXFAM in Bangladesh. Oxfam is implementing the Empowering Women Through Civil Society Actors (EWCSA) project with funding from the European Union. The initiative supports marginalized women engaged in informal and underserved sectors by strengthening the skills and capacities of local Civil Society Organizations (CSOs) and Women's Rights Organizations (WROs). Its core objective is to empower both these organizations and the women they serve to actively engage in governance, policy dialogues, and development processes.

Bangladesh faces severe climate-related hazards, with districts like Barguna & Patuakhali particularly vulnerable due to their coastal location. Fishing is a key livelihood here, yet women fisher folk are marginalized by gender norms, lacking recognition, support, and organizational representation. They face violence, wage disparities, poor working conditions, and limited access to resources, decision-making, and public services. Research shows high levels of violence and exclusion among coastal women fisher folk. Addressing these issues demands structural changes and efforts to dismantle deep-rooted gender inequalities in the fishing sector and coastal communities.

JAGO NARI is implementing "A journey to become empowered women fisher folk" under the EWCSA project in Taltoli and Rangabali Unions of Barguna and Patuakhali district, reaching 1,000 women fisher folk to promote transformative women's leadership and challenge the exploitative norms affecting their lives and work. The women fisher folk who are under our project in five types one is Manta group who are linving in floating boat on the river, Non-Manta group who fishing by using boat & net in the river, working in dry fish sector and lastly who working in fish selling center (Aroth).

## The proposed study objective:

This study aims to generate gender-responsive insights into the experiences of women fisherfolk in Barguna and Patuakhali districts. It will focus on: (1) examining the impact of climate change on their profession and livelihoods through a gender lens, highlighting how shifting environmental conditions uniquely affect women in the fishing sector; (2) To explore opportunities to enhance their wellbeing despite of climate shocks, vulnerabilities and uncertainty. The audiences of this study finding are JAGO NARI, Oxfam, European Union, policy holders, local government, CSO, WRO, academia, community people and so on. The study's findings and recommendations will be shared with national-level stakeholders through a symposium and will serve as a basis for future advocacy efforts aimed at promoting gender-equitable and climate-resilient coastal women fisher folk group.

## Scope of Work

- Document Review & Orientation: Review key project documents, including the project proposal, progress reports, and other relevant materials. The consultant will also meet with Oxfam and JAGO NARI team members involved in the project to gain contextual understanding.
- Stakeholder Interviews: Conduct interviews with policymakers, individuals, and organizations working with women fisher folk and related sectors to gather diverse perspectives and evidence.
- Consultations with Experts: Interview subject matter experts from Oxfam and JAGO NARI to understand the project's feminist and women-led approaches in promoting the rights and scopes of women fisher folk.
- Field Visits & Beneficiary Engagement: Visit project sites to interact with the 1,000 women fisher folk beneficiaries who have received project support. Collect their insights on best practices, challenges faced, and recommendations for future initiatives.
- Engagement with Local Stakeholders: Gather input from civil society representatives, local government bodies, and Upazila and district-level officials involved in or connected to fisher folk communities.
- Design & Visualization: Design the final study report using Oxfam's standard design templates, incorporating high-quality visuals including photos of participants, key documents, and data visualizations (e.g., graphs and charts).
- Final Deliverable: Submit a fully formatted digital version and hard copy books in both Bangla & English version of the final report, ready for publication and dissemination.

## Methodology

The research design will follow Convergent-Parallel Approach1 or Concurrent Triangulation Design involving simultaneous quantitative and qualitative data collection and both primary and secondary data analysis. The consultant will propose appropriate research methodology including conceptual

framework, methodological approach, study area and sampling strategy, sample size determination, data collection methods, data quality assurance, data processing and analysis, ethical consideration, limitation of the study, uptake engagement strategy etc.
